ONEMPLS GRANTS HELP OUR COMMUNITY NAVIGATE COVID-19

During the time period of April 6 and May 19, The Minneapolis Foundation has distributed nearly \$2 million in grants to 147 organizations through the OneMPLS Fund. These grants support regional efforts to address the economic impact of COVID-19, providing flexible resources to local organizations that serve communities disproportionately affected by the pandemic.

ONEMPLS GRANTS

180 Degrees, Inc.: \$15,000 to support bridge funding to provide residential services for men exiting prison.

360 Communities: \$10,000 to support a network of food shelves and a domestic violence shelter.

Aeon: \$20,000 to support the operations of an affordable housing community in Brooklyn Center.

African Career Education and Resources, Inc.: \$10,000 to support technical assistance and mini-grants for micro-businesses owned by women of color, immigrants, and undocumented residents.

African Community Services: \$10,000 to support individuals as they access unemployment assistance and other sources of income.

African Development Center of Minnesota: \$10,000 to help small-business owners access state and federal emergency assistance.

African Economic Development Solutions: \$10,000 to provide technical support and help immigrant small-business owners access state and federal assistance.

African Immigrants Community Services: \$15,000 for meals and driving services for Somali elders.

Ain Dah Yung (Our Home) Shelter, Inc.: \$15,000 to provide direct financial support to Native youth in permanent supportive housing.

All Square: \$15,000 to support living wages for All Square Fellows to continue during the initial phase of the pandemic.

Alliance Housing, Inc.: \$5,000 to create a rent forgiveness fund for tenants who lost jobs or income due to the pandemic.



Alliance of Early Childhood Professionals: \$10,000 to support distribution of traditional medicines and food from a cultural garden.

AL-Maaun: \$10,000 for meal delivery and groceries for families in the Near Northside neighborhood of Minneapolis.

American Indian Housing Corporation: \$35,000 for hazard pay to provide supportive and homeless housing for Native individuals and families.

American Indian OIC: \$10,000 for basic needs for vulnerable students.

American National Red Cross: \$20,000 to maintain front-line blood collection staff in the 7-county metro area and offer virtual services to community partners.

At Home Group Inc – Small Sums: \$10,000 to support struggling essential workers with work necessities.

Appetite for Change Minnesota: \$12,000 for a Northside meals program for health care workers and stipends for youth and families impacted by the pandemic.

Arena Dances: \$10,000 to support 20 contracted artists impacted by the pandemic.

Art is My Weapon: \$10,000 to support the families of artists with children who do not qualify for unemployment.

Asian American Organizing Project: \$10,000 to provide microgrants to Asian American youth ages 18-24 who have lost work but don't qualify for unemployment assistance.

Asian Women United of Minnesota: \$20,000 to support hazard pay and protective measures for staff and residents in an emergency shelter that serves victims of domestic violence.

Avenues for Homeless Youth: \$10,000 to support increased demand and services for homeless youth.

Babys Space – A Place to Grow: \$20,000 to address shortfalls in childcare assistance income and emergency support for families.

Basic Needs Inc. of South Washington County dba Stone Soup Thrift Shop: \$10,000 to support online food package ordering and pick-up.

Bdote Learning Center: \$10,000 to purchase and deliver food to students and families.

Beacon Interfaith Housing Collaborative: \$15,000 to support hazard work and additional cleaning of housing and shelter facilities.

Big Brothers Big Sisters of the Greater Twin Cities: \$15,000 for mini-grants to support the emergency needs of the families of mentored youth.

Black Womens Wealth Alliance: \$10,000 for operating costs and direct assistance to Black women entrepreneurs and contractors in Minneapolis.

Boys and Girls Clubs of the Twin Cities: \$10,000 for weekly meal kits for the families of youth served by the organization's programs.

CAPI USA: \$10,000 to help immigrants and refugees navigate job training, unemployment, SNAP, and other government COVID-19 response programs.

Casa de Esperanza: \$10,000 to support families experiencing domestic violence during the shelter-in-place order.

Catholic Charities of St. Paul and Minneapolis: \$30,000 to support increased staffing and food services at two Opportunity Centers.

Centro de Trabajadores Unidos en Lucha: \$15,000 to provide navigation and technical assistance to low-wage workers affected by the pandemic.

Centro Tyrone Guzman: \$20,000 to support the delivery of home meals for Latinx elders and other emergency support for families.

Christians Reaching Out in Social Service: \$10,000 to support the delivery of groceries to seniors and families in mobile home parks.

City of Lakes Community Land Trust: \$10,000 to provide housing assistance to low-income land trust owners.

Coalition of Asian American Leaders: \$15,000 to work with 40 Asian nonprofits that are providing loans and technical assistance to micro-businesses and support for elders experiencing food insecurity.

Collide Theatrical Dance Company: \$10,000 to assist contract dancers, musicians, and artists affected by COVID-19.

CommonBond Communities: \$20,000 to ensure staff continuity and support low-income residents in Twin Cities housing communities.

Community Emergency Assistance Program: \$10,000 to support the distribution of emergency food and supplies.

Community Emergency Service: \$10,000 to provide culturally specific foods to households in south Minneapolis.

Comunidades Latinas Unidas en Servicio: \$30,000 to support increased staff to provide emergency services to Latino families.

Cookie Cart: \$12,000 to adapt the curriculum to a virtual format and provide wages to youth employees.

Cowles Center for Dance and the Performing Arts: \$10,000 to support teaching artists and dance companies that have lost income due to pandemic-related cancellations.

Dar-Us-Salaam Cultural Center: \$10,000 to support food and shelter assistance for individuals and families.

East Side Neighborhood Services: \$10,000 to support food programs for older adults, people with disabilities, and other low-income public housing residents.

Ecumen: \$25,000 to purchase additional protective equipment and pantry supplies for vulnerable residents and staff.

Elpis Enterprises: \$10,000 to support basic needs and emergency grants for youth trainees in social enterprise programs.

Emerge Community Development: \$20,000 to maintain summer internships for youth ages 18-24 from North Minneapolis and the Cedar-Riverside neighborhood.

Exodus Financial Services: \$10,000 to support interest-free payday loan refinancing during the COVID-19 crisis.

Friends of Global Market: \$10,000 for advertising to help businesses stay open at the Midtown Global Market.

Gethsemane Lutheran Church: \$25,000 to support the setup of four new church food shelves in North Minneapolis.

Greater Minneapolis Community Connections: \$10,000 to provide culturally specific meals to elders and people with disabilities at 10 public housing buildings in Ventura Village and the Cedar Riverside neighborhood.

Good in the 'Hood: \$10,000 to support food stability for individuals and families.

Guthrie Theater: \$10,000 to support the launch of the Guthrie Family Fund for artists and staff in need due the closure and cancellation of contracts.

Help At Your Door: \$10,000 to support the delivery of food and supplies for seniors and differently-abled individuals.

Hennepin Theatre Trust: \$10,000 to support coaching and commissions for diverse and BIPOC artists who have lost income due to the pandemic.

HIREd, Inc.: \$12,000 for groceries and other basic needs for clients in the organization's youth training program.
Inquilinx Unidxs Por Justicia: \$10,000 to support a food bank for low-wage workers and renters, and to provide support for tenants facing eviction.

Hope Community: \$15,000 to offset reduced revenues.

House of Charity, Inc.: \$15,000 to support increased expenses and demand for meals for the homeless.

HousingLink: \$15,000 to add 24-hour support and guidance on eviction rules, tenant protection, and overcoming housing barriers.

In The Heart of the Beast Theatre: \$10,000 to support artists in getting back to work.

Interfaith Action of Greater St. Paul: \$12,000 to support a culturally specific food shelf serving the American Indian community in St. Paul.

International Institute of Minnesota: \$25,000 to support basic needs for students who are excluded from support as newly arrived refugees, survivors of trafficking, families of unaccompanied children, and those who have received asylum in the past 90 days.

Involve MN: \$10,000 to provide professionally prepared box lunches to people experiencing homelessness.

Jeremiah Program: \$18,000 for groceries, diapers, and basic supplies for low-income families, and for operating costs to mitigate the impact of lost rent revenue.

Jungle Theater: \$10,000 to pay artists and theater technicians who have lost work due to pandemic-related cancellations.

JustUs Health: \$10,000 to provide support and financial assistance for individuals with HIV.

Juxtaposition Arts: \$25,000 to support paid youth apprentices for youth-staffed art and design center.

Ka Joog: \$25,000 to support services for Somali and New American youth that are coordinated by Ka Joog and the African American Development Association.

Keystone Community Services: \$10,000 to support increased staffing and expenses for their food shelf.

Korean Service Center: \$12,000 to provide medical supplies, shopping assistance, and other support for low-income seniors in public housing.

Lake Street Council: \$10,000 to support vulnerable business owners applying for emergency financing and loans.

Latino Economic Development Center: \$10,000 to provide small-business owners with technical assistance and access to emergency aid.

Launch Ministry: \$12,500 to support food, basic needs supplies, and emergency shelter for homeless youth in Carver and Scott counties.

Loaves and Fishes Too: \$20,000 to support mobile meals and groceries for individuals and families.

Lowry Hill East Neighborhood Association: \$10,000 to create a work loss fund for residents.

Lutheran Social Services: \$15,000 to support shelter capacity and cleaning and basic needs for homeless youth.

Main Street Project: \$10,000 to support immigrant and undocumented farmers.

Metro Meals on Wheels: \$10,000 for additional staffing and other expenses to provide meals to isolated low-income seniors.

Metropolitan Economic Development Association: \$15,000 to provide technical assistance to minority-owned businesses in Minneapolis.

Minnesota Africans United: \$14,000 to provide food, rental, utility, and other emergency assistance to African immigrant front-line workers and their families.

Minnesota Dawah Institute: \$10,000 to support meals and groceries for seniors, youth counseling/support via phone, temporary housing, and basic needs items in St. Paul.

Minnesota Indian Women's Resource Center: \$10,000 for food, cleaning supplies, and rental assistance for clients.

Minnesota Multicultural Media Consortium: \$10,000 to continue Latino broadcasting to inform residents of services and conduct call-in segments about the pandemic.

Mixed Blood Theatre Company: \$10,000 to commission emerging artists in the Cedar-Riverside area to produce storytelling work related to health concerns.

Model Cities of St. Paul: \$10,000 for basic needs and rental assistance for Model Cities families.

MoveFwd, Inc.: \$20,000 to support middle and high school students experiencing homelessness.

MOVO SPACE: \$10,000 to provide bridge funding to help the organization navigate loss of income from rental of its creative space.

Native American Community Development Institute: \$25,000 to support Native artists and Native-owned businesses.

Neighborhood Development Center: \$10,000 to provide small-business owners with technical assistance and support as they access state and federal assistance.

Network for Better Futures: \$25,000 to support emergency assistance, meals, and support services for formerly incarcerated clients and social enterprise warehouse staff.

New American Development Center: \$10,000 to provide technical support to low-income immigrant families experiencing job loss and business closures.

NorthPoint Health & Wellness Center, Inc.: \$10,000 to provide flexible housing assistance to single adults affected by the pandemic.

Northside Economic Opportunity Network: \$10,000 to support grants and technical assistance for small-business owners in North Minneapolis.

OutFront Minnesota Community Services: \$10,000 for basic needs, rental assistance, utility payments, and other supports for low-income LGBTQ gig workers and survivors of violence.

Penumbra Theatre Company: \$10,000 to support artists and staff members affected by the pandemic.

Pillsbury United Communities: \$30,000 to support food shelves, free prepared meals in Minneapolis, and artist stipends.

Prepare + Prosper: \$10,000 to help people file Economic Impact Payments remotely and connect to safe and affordable direct deposits.

Presbyterian Homes Foundation: \$10,000 to offset increased costs of food, meal production, and home delivery due to the pandemic.

Prince of Peace Lutheran Church – Mission Outpost: \$25,000 to support food, clothing, and basic needs assistance for families in Dakota and Scott counties.

PRISM: \$10,000 to offset increased food and staffing costs at a food shelf in the western suburbs.

Project for Pride in Living, Inc.: \$20,000 to support hazard pay for essential building staff and basic needs services for residents who have lost income.

Ragamala Music and Dance Theater: \$27,830 to support local artists, teachers, and staff during pandemic-related cancellations of classes and new works.

Red Eye Collaboration: \$10,000 to support payments for artists and contractors impacted by the postponement of the 2020 season.

Resources, Justice & Management: \$20,000 to support gig workers in the beauty industry.

Restaurant Opportunities Centers ROC United, Inc.: \$20,000 to provide stipends and employment services for hospitality and restaurant workers.

Rum River Art Center, Inc.: \$10,000 to support artists providing virtual face-to-face classes for older adults.

Safa Marwa Relief and Development Organization: \$10,000 to provide food, cleaning supplies, and other basic needs to people who are blind, deaf, or living with other disabilities.

Second Harvest Heartland: \$15,000 to support the distribution of food boxes with fresh fruits and vegetables to Minneapolis residents.

Seward Redesign, Inc.: \$10,000 to support 41 business tenants in the Seward neighborhood.

Sholom Foundation: \$16,000 to help ensure continuity in residential services for the elderly by offsetting increased staffing and other costs.

Simpson Housing Services, Inc.: \$14,000 to support hazard pay for staff as well as food and cleaning supplies for single adults and families in emergency shelter and housing.

Somali Community Resettlement Services: \$10,000 to assist immigrants and refugees in Minneapolis with unemployment services, food, and transportation needs.

Soo Visual Arts Center: \$12,000 to support virtual programming and commissioning short projects/work from local artists.

Southeast Seniors, A Living at Home Block Nursing Program: \$10,000 to support the home delivery of essential basic needs for older adults.

Southern Anoka Community Assistance: \$10,000 to support food shelf operations and delivery to low-income individuals and families in Northeast Minneapolis and Anoka County.

Springboard for the Arts: \$15,000 to support the Personal Emergency Relief Fund for BIPOC and Native artists.

St. Stephen's Human Services: \$10,000 to support expanded emergency shelter and street outreach for homeless individuals in Minneapolis.

TaikoArts Midwest: \$10,000 to support an emergency relief fund for Taiko artists and teachers.

The Aliveness Project: \$16,000 for meals and groceries for low-income people living with HIV.

The Bridge for Youth: \$10,000 to offset the additional costs of providing shelter and ensuring the safety of homeless youth during the pandemic.

The Dwelling Place: \$10,000 to support women and children leaving abusive situations.

The Link: \$15,000 to support health and safety precautions in shelter and housing programs for homeless youth.

The Neighborhood Hub: \$15,000 to support food, housing assistance, basic needs supplies, and employment search assistance in North Minneapolis.

Toward Renewed Unity and Service Together: \$12,000 to provide meals, groceries, and chore assistance to seniors in South Minneapolis.

Tubman: \$10,000 for transitional housing, meals, and support services for youth who have experienced sexual exploitation and relationship violence.

Twin Cities Community Gospel Choir: \$10,000 to pay contractors affected by the cancellation of the choir's Spring 2020 season.

Twin Cities Recovery Project, Inc.: \$10,000 to provide additional financial support to those struggling with substance abuse and mental health issues.

Upstream Arts, Inc.: \$18,000 for artists to provide virtual programming for individuals of various abilities.

Urban Boatbuilders, Inc.: \$10,000 for wages for youth apprentices.

Urban Roots: \$10,000 for internships for underserved youth to maintain urban gardens and farms on the East Side of St. Paul.

Urban Ventures Leadership Foundation: \$25,000 to provide rent and utility assistance to undocumented families.

Vietnamese Social Service of Minnesota: \$10,000 to support Karen, Kareni, and Vietnamese refugees and immigrants in need of basic supplies and services.

Way to Grow: \$15,000 to conduct virtual home visits to meet education and human service needs of children and their families.

West Bank Business Association: \$10,000 to help West Bank businesses navigate the pandemic.

WomenVenture: \$15,000 for technical assistance for women-owned businesses impacted by closures.

YMCA of the Greater Twin Cities: \$15,000 for basic needs, support services, and housing expenses for unaccompanied youth in Minneapolis.
