### **Generational Shifts**

- The Great Wealth Transfer. The biggest generational wealth transfer in history is underway, with the children of Baby Boomers set to inherit an estimated \$84 trillion by 2045.
- A Next-Gen Revolution. Research shows what we already know: Younger people do not always share the values and motivations of their parents. From the goals that drive their giving to where they get their news, these rising leaders think differently in ways that are already transforming philanthropy.
- Beyond Grantmaking. Many younger people are eager to get close to communities not only by donating money, but by contributing time, talent, and testimony to causes they care about.

# **Philanthropic Shifts**

- Trust-Based Philanthropy. This movement aims
  to shift power to the people most affected by
  community challenges, inviting funders to partner
  with nonprofits in a spirit of collaboration rather
  than control.
- Giving While Living. Many donors are shifting their focus to distribute wealth during their lifetimes rather than in their wills.
- The Rise of Donor Advised Funds. In 2023, more than \$250 billion was held in Donor Advised Funds. As these funds continue to grow in popularity, so does the need for resources to support fundholders as they put these charitable assets to work in the community.
